The Potomac Afghan Hound Club and the Show Secretary have no obligation or responsibility for providing service through a public address system or steward or runners for the purpose of calling or locating dogs that are not brought into the ring when required.

ALL DOGS PRESENT MUST BE HELD ON LEASH or confined to their crates except when being judged.

**NO GASOLINE OR DIESEL GENERATORS** are permitted within 100 feet of the tent or show ring.

CASH PRIZES WILL BE PAID IN THE RING TO THE PERSON SHOWING

**THE DOG**. Claims for cash prize money must be made in the show ring before judging is over for the show. The Potomac Afghan Hound Club and the Show Secretary disclaim any liability for cash prizes after the judging of the show is over.

The showing of unconfirmed Champions in Best of Breed competition is limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship. 3. (Event Class) Consult the classification in this premium list. If the event class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering vour dog, i.e. age division, color division, weight division,

4. A dog must be entered in the name of the person who actually owned it at the time entries for an event closed.
